# **PROFILES**

### PHILIPPINE GOVERNMENT

Ambassador MYLENE DE JOYA GARCIA-ALBANO is the first female Ambassador of the Philippines to Japan. She is an accomplished lawyer and bar topnotcher, with a long and distinguished career in the government service.

She graduated with Second Honors from the Ateneo de Manila University's College of Law in 1990. She earned her Bachelor of Arts degree in Political Science from the George Washington University in Washington, D.C. in 1982 and an Associate of Arts degree in Liberal Arts from Marymount College in Palos Verdes, California in 1980.

Prior to her appointment as Ambassador, she was a Member of the Board of Directors of the Davao City International Airport Authority.

She was the first female elected to represent the 2nd District of Davao City in the House of Representatives. She served three consecutive terms as Congresswoman from 2010-2019.

Secretary **Frederick D. Go** is the Special Assistant to the President for Investment and Economic Affairs. He serves as Chairperson of the Economic Development Group or the EDG, and is directed to supervise and monitor, on behalf of the President, the NEDA, DOF, DBM, DTI, and their respective attached agencies. He also sits as Member of the NEDA Board Committees and the Fiscal Incentives Review Board (FIRB).

His office is tasked to ensure the effective integration, coordination, and implementation of the various investment and economic policies and programs of the Government. He is likewise mandated to drive the timely delivery of investment projects, trade agreements and pledges, including those originating from international state visits and foreign trips.

Before joining government, he served as Chairman, Vice-Chairman, President, CEO, and/or Director in six (6) listed companies and over 100 corporations in various industries including media, retail, real estate, food, banking, finance, airline, airport, petrochemicals, gaming, and power over a span of 35 years.

Prior to his appointment as SAP-IEA, he was the Presidential Adviser for Investment and Economic Affairs for a year.

**Ralph Gonzalez Recto** is the current Secretary of the Department of Finance (DOF).

His extensive political career includes three terms in the Senate (from 2001 to 2007 and from 2010 to 2022), where he held key positions such as Senate President Pro Tempore (16th to 18th Congress) and Senate Minority Leader (17th Congress). He started his political career as the Representative of the 4th District of Batangas from 1992 to 2001.

As a seasoned legislator, he pursued critical fiscal and economic reforms meant to address the cost of living, generate meaningful employment, and expand the country's fiscal space.

He also previously served as the Socioeconomic Planning Secretary of the National Economic and Development Authority (NEDA) in 2008.

Department of Budget and Management Secretary **Amenah F. Pangandaman** is the first Filipina Muslim Budget Chief. She is also the only female member of the country's Economic Team and the only Filipina Muslim in the Cabinet of President Ferdinand R. Marcos Jr.

She is currently chairperson of the Development Budget Coordination Committee, the Philippine Open Government Partnership, and the Government Procurement Policy Board. She is also Co-Chair of the Intergovernmental Relations Body, leading discussions, and initiatives to empower the Bangsamoro Autonomous Region in Muslim Mindanao.

Sec. Mina has over 20 years of experience in government service. She was Assistant Governor of the Bangko Sentral ng Pilipinas, Undersecretary at the Department of Budget and Management, and Chief-of-Staff of former Senate President Edgardo Angara. This diverse background has inspired her transformational leadership as she passionately introduces reforms on inclusivity, sustainability, transparency, and bureaucratic efficiency, as encapsulated in the PBBM Administration's Agenda for Prosperity.

**Dr. Arsenio M. Balisacan** is the government's chief economic planner and secretary of the National Economic and Development Authority, a post he had previously held from 2012 to 2016. He also served as the founding chairperson and chief executive of the Philippine Competition Commission from 2016 to 2022.

Before his initial Cabinet appointment in 2012, he was professor and dean of the University of the Philippines School of Economics, director-chief executive of the Southeast Asian Regional Centre for Graduate Study and Research in Agriculture (SEARCA), and undersecretary of the Department of Agriculture. Before joining the University of the Philippines faculty in 1987, he was a research fellow at the East-West Center in Honolulu, Hawaii, and an economist at the World Bank in Washington, DC.

He has authored and co-edited seven books and published, both locally and internationally, close to 100 academic papers and book chapters on various development issues, particularly in the Philippines and East Asia. He is also the author and co-editor of the upcoming book *Designing Competition Policy for Economic Development in Asia.* 

**Dr. Francisco G. Dakila, Jr.** is the Deputy Governor of the Monetary and Economics Sector. He provides highly technical advisory support on matters relating to the formulation, implementation and assessment of policies and programs in the areas of monetary, external, real, and financial sectors.

Previously, he worked at the US Agency for International Development (USAID) and at the Agricultural Credit Policy Council. He also taught at the University of the Philippines School of Economics and at the De La Salle University in Manila.

He received his PhD and MA in Economics and BS in Economics (magna cum laude) from the University of the Philippines-School of Economics. He has published papers at the Philippine Review of Economics, Philippine Statistician, Bangko Sentral Review, and BSP Working Paper series, and chapters in several BSP publications, including Money and Banking in the Philippines: Perspectives from the Bangko Sentral ng Pilipinas, and Philippine Central Banking: A Strategic Journey to Stability.

**Alfredo E. Pascual** is the Secretary (Minister) of the Department of Trade and Industry (DTI). At the time of his appointment to DTI in June 2022, he was the President of the Management Association of the Philippines (MAP).

Over the past four decades, Mr. Pascual has contributed to society by serving at four esteemed national and international institutions: the Institute of Corporate Directors (ICD), University of the Philippines (UP) System, Asian Development Bank (ADB), and Asian Institute of Management (AIM). Prior to joining DTI, Mr. Pascual has also been an independent director on the board of publicly listed companies, such as SM Investments and Megawide Construction.

He holds an MBA and BS in Chemistry (cum laude) from UP. His awards included Honorary Doctorates from the University of the Philippines and four other universities, the Presidential Lingkod Bayan Award from Malacanang, and the Rotary Golden Wheel Award for Higher Education.
